INTRODUCTION

The Inter-institutional Working Group against Racism in Policing (GTI Racism) was created by Ordinance No. 5 of the 7th Chamber on November 27, 2020 and is linked to the 7th Coordination and Review Chamber (7th CCR). The GTI Racism has the following objectives: identify racism within the scope of federal law enforcement agencies; propose actions and measures to eliminate discriminatory conduct; foster public debate on racism in law enforcement institutions and policing, among others.

The group includes members of the Federal Prosecution Service, researchers on police violence and institutional racism, representatives of civil society organizations (*Luta pela Paz, Instituto Brasileiro de Ciências Criminais, Instituto Cidade Segura, Educafro and Rede Nacional de Mães e Familiares de Vítimas do Terrorismo do Estado*), representatives of the Federal Police and the Federal Highway Police, as well as the Federal Public Defender's Office. The National Council of the Prosecution Service (CNMP) and the National Secretariat for Penal Policies (Senappen) are permanent guests on the GTI.

The GTI Racism work plan was divided into three stages: diagnosis, articulation and recommendations. In the articulation stage, an internal seminar was held in 2021 and 2023, a public hearing in 2022, as well as a Collection of Articles - Racism in Policing was published in 2023.

In the diagnosis stage, data was requested from the Federal Police, the Federal Highway Police and the National Secretariat for Penal Policies, in addition to gathering the work of the Federal Prosecution Service related to the GTI's theme. Based on the review of the data, a **Diagnostic Report** was prepared, divided into three axes: *Axis 1 - Racial and Ethnic Profiling of the Prison and Public Security Systems; Axis 2 - Police Training; and Axis 3 - Anti-Racist Action Protocol.*

The main conclusions of the diagnosis were: lack of data and organizational cultures with no tradition of accountability; male and white police; a slightly more egalitarian criminal police; low capacity to investigate crimes of racism and few charges; absence of anti-racist education in police training activities, which indicates a lack of institutional self-criticism regarding institutional and structural racism; lack of relevant information on issues related to race, ethnicity and gender in the norms reviewed; lack of a specific protocol regarding the production of data or actions in relation to the ethnic-racial issue.

During the recommendations stage, members of the 7th Coordination and Review Chamber, members of the GTI Racism, representatives of the Federal Police (PF), the Federal Highway Police (PRF), the National Secretariat for Penal Policies (Senappen), as well as representatives of civil society met at the headquarters of the Office of Federal Circuit Prosecution of the 2nd Region, in the city of Rio de Janeiro, for a **Seminar called Racism in Policing: Perspectives and Challenges**.

At the **Racism in Policing: Perspectives and Challenges Seminar**, 43 recommendations were made covering the three axes of the review: Axis 1 - Racial and Ethnic Profiling of the Prison and Public Security Systems ; Axis 2 - Police Training; and Axis 3 - Anti-racist Action Protocol.

43 RECOMMENDATIONS FOR COMBATING RACISM IN POLICING

AXIS 1 - RACIAL AND ETHNIC PROFILING OF THE PRISON AND PUBLIC SECURITY SYSTEMS (10 RECOMMENDATIONS)

- 1** Send public databases (disaggregated spreadsheets) to the MPF and make them available to the public with information useful for the external control of police action, according to a technical note to be prepared by the 7th Chamber.

AXIS 3 - ANTI-RACIST ACTION PROTOCOL (14 RECOMMENDATIONS)

- 1** Prepare a technical note in respect to the cultural identity of black people in prison, such as haircuts and body religious rites.

9 Create a consolidated national database with information on the initiation of internal disciplinary procedures (IDPs) based on race and color, gender identity, religion and sexual orientation.
